Information Sheet Regarding Transition Saskatchewan Oral Health Coalition to Saskatchewan Oral Health Coalition Inc.

In furtherance of the mandate of Saskatchewan Oral Health Coalition (Coalition) the Leadership Team has proceeded with the initial steps to incorporate a non-profit charitable corporation under *The Non-profit Corporations Act, 1995* to take over the operations of the Coalition. Saskatchewan Oral Health Coalition Inc. (SOHC Inc.) was incorporated on September 26, 2017. It is proposed the work of the Coalition be continued as a charitable corporation instead of carrying on in its current state, being an unincorporated association of individuals and organizations. The Leadership Team is also working on an application to register SOHC Inc. as a registered charity under the *Income Tax Act*.

The current listed directors and initial members for SOHC Inc. are:

Leslie Topola Kellie Watson Parviz Yazdani Jerod Orb Susan Anholt

To complete the transition a formal Asset Transfer Agreement to transfer the assets and operations of the Coalition, the unincorporated association, to SOHC Inc., the non-profit corporation, is needed. A further package will be circulated in advance of the May 14, 2018 meeting which will contain a resolution to be signed by all existing members of the Coalition to:

- approve the agreement to transfer all of the assets, liabilities and operations to the new corporation;
- authorize two named members of the Coalition to bind the Coalition by signing the agreement as agents of the Coalition;
- authorize the dissolution and liquidation of the Coalition after the transfer of assets and operations to the new corporation is complete.

All members of the Coalition will need to apply for a new membership in SOHC Inc. A membership application form will be included in the further package of materials to be circulated.
